CLINTON CITY EMERGENCY NOTIFICATION SYSTEM

Now is a good time to sign up for the Clinton City Emergency Notification System. To do so, click on the **Red Phone** (below) or go to www.clintoncity.com and click on the **Red Phone** there.

By registering, you can specify how you will receive notifications and you can keep your profile updated with accurate contact information to insure you are notified of important information or of an emergency.



EMERGENCY NOTIFICATIONS

In late 2019, Clinton City upgraded to a new notification provider tied directly to our website. If you previously signed up and have not logged in prior to December 2019, due to the migration to the new system, it may be necessary to recreate your password. We have made every effort to transfer as much contact information as possible. To recreate your password click on the link <https://clintoncityut.regroup.com/login> or retype it in your browser, choose login, then put your email address in and choose the reset password option, this will cause the system to send you a password reset link. With this new system, an email is required; if you do not have an email address please contact Lisa at 801-614-0700.

Please note that our Emergency Notification System is automatically and regularly updated through our Utility Billing system. If your information on file is not accurate, and you have not registered on our website, you may **NOT** receive EMERGENCY NOTICES. Please call our Utilities Department at 801-614-0700 to update your billing contact information.

If you are an owner of a rental property, please **ENCOURAGE** your renters to register for notifications on our website, as this is the only way they will receive notifications or alerts. Thank you!

Unless it becomes necessary to close our City offices, we are available to serve our residents. All essential city services will continue. However, in an effort to follow Governor Herbert's directive to "stay safe, stay home" and to implement social distancing practices to protect our citizens, community and employees from the spread of Corona Virus, Clinton City is encouraging residents to pay their utility bill thru Express Bill Pay at www.clintoncity.net, over the phone by calling **801-614-0700** or by placing your payment in the utility payment dropbox located in the City Offices parking lot at 2267 N 1500 W.

We would like to encourage our residents to consider paying their utility bill online by signing up for our online payment service provider Xpress Bill Pay which is **FREE** of charge.

To sign up, start from the official Clinton City Web Site at www.clintoncity.net and click **PAY MY UTILITY BILL**. Once your account has been created, some of the other enhancements with this service include the ability to securely view complete bill details, view payment history and signing up for reoccurring payments.

A MESSAGE FROM OUR POLICE DEPARTMENT

The Police Department would like to remind everyone to practice and observe pedestrian safety. Pedestrians, please use crosswalks and designated crossings. Motorists, please honor pedestrian right of ways and be mindful and observant of those outdoors while driving.

Also with warmer weather we will see an increase in road construction projects. We would like to take this opportunity to educate residents on Road Closed signs and traffic control devices. There are two types of Road Closed signs being utilized:

1. Road Closed (Local Traffic Only). Generally speaking, Road Closed (Local Traffic Only) means the road is closed unless your destination is within the road closed boundary, or between the signs. The road is not open or meant to be used as a thoroughfare, but may be accessed to arrive at a destination within the boundary. Please keep in mind local traffic only does not allow passage through the second road closed area.
2. Road Closed. A Road Closed sign with no local traffic designation means Road Closed. This is a hard closure with no vehicle access permitted. The only exceptions are construction and emergency vehicles, or if directed by a construction flagger or officer. There is no access or vehicle pass through permitted in this area, even if your destination is within the local traffic boundary. The roads in this designation remain closed 24 hours a day, whether or not there are workers present.

Please obey Road Closed signs in construction areas.

The Police Department will continue to post COVID-19 and other important updates on social media. Thank you for your understanding and cooperation. Please take care of yourselves, loved ones, and each other and continue to practice kindness and consideration in our community during this time.

2020 CENSUS OPERATIONAL ADJUSTMENTS DUE TO COVID-19

A United States Census takes place every ten years. Utah has an estimated 3.21 million people. The amount of federal funding Utah receives for healthcare, education and transportation is dependent on census participation. In recent years, that funding accounted for 28% of the state budget. It also has a significant impact on our local communities.

Tree/Shrub Trimming Reminder: It is the homeowner's responsibility to maintain all trees and shrubs in their park strip. Please get them trimmed now so that the street sweeper can sweep your street this summer. The City Code (25-16-5) states: "All shrubs and trees shall be pruned to permit plain view of regulatory (street and stop) and caution signs, utility accesses, and so that they do not overhang the curb in the street twelve (12) feet or the sidewalk eight (8) feet."

CLINTON CITY ROAD PROJECTS UPDATE

- **1300 N 1000 W Roundabout, March 2020 to June 2020**
 The Davis & Weber Counties Canal Company is upsizing their water line on 1300 N from the D&RGW Trail to 1000 W. When their project is complete, Clinton City will construct a larger roundabout at this intersection. The intersection will be closed to traffic until construction is complete.
 - **800: N 2000 W to 2525 W - March 2020 to September 2020**
 This project will update utilities and widen the road with curb, gutter and sidewalk. As funding permits, this project will be extended to 3000 W. 800 N will be closed from 2000 W to 2525 W.
 - **1300 N: 2000 West to 2200 West - April 2020 to May 2020**
 Waterline replacement project in preparation for street improvements this fall or next spring. Partial/limited street closures will occur as the waterline is installed.
 - **Lazy L Subdivision - 630 W 1400 N- April 2020 to June 2020**
 This project will install a new storm drain system and reconstruct the roadway. The street will be open to local traffic only during construction.
 - **Replace Pedestrian Ramps – April 2020 to June 2020**
 Replace 45 intersection ramps for ADA compliance in various locations.
 - **Road Surface treatments- May 2020 to June 2020**
 Surface treatment to roads in Clinton. 2300 N: 500 W to 1000 W, Sun Ray subdivision, 630 W: 1800 N to 2300 N, and other locations. These streets will be temporarily closed on the days the surface treatments are placed.
 - **Cemetery trailhead – Feb 2020 to May 2020**
 A trailhead is under construction at the cemetery for the D&RGW trail and consists of a parking lot, new restroom, drinking fountain, and trail access.
 - **Sewer lining 2000 W 1800 N to 2050 N – April 2020 to May 2020**
 The city is lining existing sewer lines on 2000 West prior to UDOT widening the roadway. Traffic will be routed around equipment and bypass pumping. Traffic lanes on 2000 West will not be closed.
 - **1600 N 2700 W storm drain – April 2020 - May 2020**
 The city will be installing storm drain at the intersection in preparation for street rebuild. Traffic will be impacted as the construction crosses the road.
 - **Meadows Park – Summer 2020 – Spring 2021**
 The city will be making improvements to Meadows Park by replacing the existing tennis courts with pickleball courts, replacing the playground equipment with an all abilities playground, ADA access improvements around the park, and reconstructing the parking lot. The project is partially funded by a Federal Grant. Design and Construction will begin after agreements for the funding are in place.
- We appreciate your patience and understanding while these important projects are being completed in our City.

**2019 Water Quality Report
Clinton City**

We are pleased to present to you this year's Annual Water Quality Report. This report is designed to inform you about the quality of the water, the services we deliver every day and what it means to you, our customer. Our prime goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water system and protect our water resources. We are committed to ensuring the quality of your water.

Where does my water come from?

The majority of our water is supplied by several reservoirs, the Weber River and creeks along the Wasatch Front. This surface water is treated by and purchased from the Weber Basin Water Conservancy District. Deep well water is used to supplement the surface water resources, if necessary.

Monitoring

Clinton City's drinking water is routinely monitored for components in accordance with Federal and Utah State laws. The following table shows the results of monitoring for the period of January 1st to December 31st, 2019. The following definitions will help you understand the terms and abbreviations.

Non-Detects (ND) - laboratory analysis indicates that the constituent is not present.

Range: Low to high - For water systems that have multiple sources of water, the Utah Division of Drinking Water has

given water systems the option of listing the test results of the constituents in one table, instead of multiple tables. To accomplish this, the lowest and highest values detected in the multiple sources are recorded in the same space in the report table.

Parts per million (ppm) or Milligrams per liter (mg/l) - one part per million corresponds to one minute in two years or a single penny in \$10,000.

Parts per billion (ppb) or Micrograms per liter (ug/l) - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

Picocuries per liter (pCi/L) - picocuries per liter is a measure of the radioactivity in water.

Nephelometric Turbidity Unit (NTU) - nephelometric turbidity unit is a measure of the clarity of water. Turbidity in excess of 5 NTU is just noticeable to the average person.

Maximum Contaminant Level (MCL) - The "Maximum Allowed" (MCL) is the highest level of a contaminant that is allowed in drinking water.

Maximum Contaminant Level Goal (MCLG) - The "Goal" (MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Arsenic, Lead, Nitrate, Radon and Cryptosporidium are regulated more closely. Notice of *any* detection is required. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Clinton City is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. What does this mean?

MCL's are set at very stringent levels. To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the MCL for a lifetime to have a one-in-a-million chance of having the described health effect.

Why are there contaminants in the water?

All sources of drinking water are subject to potential contamination by constituents that are naturally occurring or are man made. Those constituents can be microbes, organic or inorganic chemicals, or radioactive materials. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline (800-426-4791).

Should special precautions be taken?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to

lessen the risk of infection by cryptosporidium and other microbiological contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

Source Protection

Clinton City has a Drinking Water Source Protection Plan that is available for review to our customers at our public works office. It provides more information on potential sources of contamination and our source protection areas.

Cross Connection

A cross connection is any actual or potential connection between the water you want to drink and other sources of undesirable substances (e.g., used water, irrigation water, industrial fluids, etc.) to enter your drinking water. Through our cross-connection control program we provide oversight and monitor connections to our system to alleviate the possibility of water back-flowing from a consumer, either residential or commercial, into our distribution system. You can do your part by monitoring your own water use and connections within your home or business.
